

00 ch. to a stone X on top of Mountain; thence S. 45 W. 25.00 ch. to a stone; thence a south-east course to a sour wood corner on new road; and thence with the new Gap Creek Road to the beginning corner; said John H. Goodwin thereafter conveyed 50 acres of said land to Frank Morgan, and the remaining 450 acres were sold by his executors, W.B. and J.P. Goodwin, to Thomas Wilson, by deed bearing date February 21, 1900, and recorded in said office on March 3, 1900, in Deed Book "D.D." at page 779; said Thomas Wilson having conveyed the same to me by his said deed bearing date April 27, 1903;

Also all that tract containing sixty-two (62) acres, more or less, on two small branches of Neal's creek of Tyger River, bounded by lands now or formerly of D.W. Hodges, John H. Goodwin, W.W. Robertson, and others, beginning at a stake 3x by a chestnut oak on the side of the mountain, and running thence S. 6 W. 8.00 chains to a pine 3x; thence N. 89 W. 39.50 ch. to a white oak on corner of Turner's land; thence N. 70 W. 1.33 ch. to a Spanish oak 3x; thence N. 40 E. 40 links to a dogwood 3x; thence N. 6 W. 28.03 ch. to a stake 3x; thence S. 40 E. 7.75 ch. to a stake 3x, pine pointers; thence S. 68 1/2 E. 42.00 chains to the beginning corner; this being the same land which was sold by the commissioner in equity for Greenville District, as the property of J.W. Hodges, deceased, to Massena Taylor; and by Taylor to Moses C. Goodlett; and by Goodlett to Samuel Austin on the 15th. day of October, 1870; and by Austin to John Goodwin, by deed bearing date April 27, 1871, and recorded in said office on March 5, 1872, in Deed Book "D.D." at page 456; and by said W.B. and J.P. Goodwin, executors of said John H. Goodwin, to said Thomas Wilson; and by said Thomas Wilson to me by the deeds hereinabove recited:-

Also all that tract on the east end of Glassy Mountain, on waters of Tyger and North Saluda Rivers, beginning on a chestnut 3xom, and running thence with Harris Pittman's line to a hickory 3xom; thence with Alexander Pruitt's line to a chestnut 3xnm; thence with said line to a pine 3xnm; thence to a double chestnut 3xom; thence with Joshua Lindsay's line to a chestnut 3xom; thence with said line to a stake 3xnm; Holland Pruitt corner; thence with Massena Pruitt's line to a dogwood 3xnm; thence with said line to a chestnut oak 3xnm, M. Pruitt's corner; thence with Patience Pittman's line to the beginning corner; this tract of land, containing one hundred and eighty (180) acres, more or less, being the same which was conveyed by Joshua Pruitt to the said John H. Goodwin by deed bearing date November 18, 1882, and recorded in said office on September 1, 1884, in Deed Book "P.P." at page 724; and by said W.B. & J.P. Goodwin, executors of said John H. Goodwin, to said Thomas Wilson, and by said Thomas Wilson to me, by the deeds hereinabove recited;

Also all that tract containing one hundred and fifty (150) acres more or less, on the waters of Devil's Fork of Middle Saluda River, beginning at a Spanish oak 3xom, and running thence N. 2 E. 14.26 chains to a Spanish oak 3xom; thence N. 3 E. 12.90 ch. to a chestnut 3x; thence N. 86 W. 11.75 ch. to a pine 3x; thence S. 10 W. 14.60 ch. to a stone; thence S. 58 W. 27.25 ch. to a pine 3x; thence N. 60 W. 7.00 ch. to a forked chestnut oak 3x; thence S. 42 W. 3.00 ch. to a rock 3xom, the first of a ridge; thence S. 12 1/2 W. 6.40 ch. to a hickory 3x; thence S. 7 W. 29.50 ch. to a pile of rocks 3x; thence S. 65 E. 4.24 ch. to a Spanish oak 3xom, (gone); thence N. 52 E. 58.75 ch. to the beginning Spanish oak; this being a portion of a tract of land sold as the property of C.A. Southerlin by Massena Taylor, Sheriff of Greenville District, to E.S. Irvine, by deed bearing date July 3, 1848,

and recorded in said office on July 11, 1848, in Deed Book "V." at page 398; and devised by the last will and testament of said Edward S. Irvine, deceased, to his wife, Ann J. Irvine (see probate records, apartment 33, file 381); and conveyed by said Ann J. Irvine to said John H. Goodwin, by deed bearing date February 1, 1875, and recorded in said office on February 4, 1875, in Deed Book "G.C." at page 137; and conveyed by said W.B. and J.P. Goodwin, as executors of said John H. Goodwin, deceased, to said Thomas Wilson, and by the said Thomas Wilson to me, by the deeds hereinabove recited;

Also all that tract of land containing four hundred and forty-six (446) acres, more or less, on Walnut Hollow Mountain, on waters of North Saluda River, Sewardum Creek and Hodges Mill Creek, lying partly or entirely in Saluda Township; being the same tract of land conveyed by Elisha and G. F. Pruitt to said John H. Goodwin, by deed bearing date July 2, 1861, and recorded in said office on May 12, 1863, in Deed Book "G.C." at page 721; and conveyed by said W.B. and J.P. Goodwin, as executors of said John H. Goodwin, deceased, to said Thomas Wilson, and by the said Thomas Wilson to me, by the deeds hereinabove recited; this tract being made up of eight distinct tracts of land, full descriptions of which will be found by reference to deeds recorded in said office as follows: in Deed Book "F.F." at page 335; in Deed Book "H.H." at page 323; in Deed Book "H.H." at page 362; in Deed Book "H.H." at page 364; in Deed Book "E.E." at page 640; in Deed Book "H.H." at page 364; and in Deed Book "X.X." at page 184; the description in said various deeds being hereby expressly adopted as a part of the description of this deed;

Also all those two tracts on Middle Saluda River, containing in the aggregate four-hundred and forty-seven (447) acres, more or less; being the same granted by the State of South Carolina to George F. Townes in 1831 (see Location Book "B.B." at pages 124 and 149, in said office), and conveyed by said George F. Townes to A.B. Crook by two deeds, as follows: a deed to 900 acres on Fall creek of Middle Saluda River, including a pinnacle of Saluda Mountain, called Rich Mountain, bounded by a line running from a stone erected on the top of the mountain at the time of the establishing of the dividing line between the state of North and South Carolina S. 10 W.; by lands laid out by Jeremiah Cleveland Sr.; on the south east by the Middle Fork of Saluda River; on the north and north-west by the North Carolina line; and on the west by vacant land; this deed bears date July 20, 1847, and was recorded in said office on July 27, 1847, in Deed Book "V." at page 251; the second deed conveyed 487 acres commencing at a white oak 3x on the line of north and South Carolina, and running thence S. 20 E. 70.00 chains to a stake on Middle Fork of Saluda River; thence up the meanderings of said river to a stake; thence North 30.00 chains to a hickory on the dividing line between North and South Carolina; thence along the said state line to the beginning corner; this deed bears date April 26, 1853; and was recorded in said office on June 3, 1853, in Deed Book "W." at page 528; the plats of both these tracts, as originally surveyed, being on record in said office in Location Book "B.B." at pages 124 and 149 respectively; the heirs of said A.B. Crook deceased (by their attorney in fact, T.O. Donaldson, appointed under written power of attorney, bearing date January 28, 1879, and recorded in said office on February 14, 1880, in Deed Book "K.K." at page 267) having conveyed both of said tracts of land to the late William C. and John H. Goodwin, by deed bearing date February 9, 1880, and recorded on the same day in said office, in Deed Book "K.K." at page 244; the undivided one-half interest in said land owned by the said John H. Goodwin having been conveyed by his executors, W.B. and J.P. Goodwin, to said Thomas Wilson, and by said Thomas Wilson to me by the deeds hereinbefore recited; the undivided one-half interest therein owned by the said
