Dollars, to us in hand paid at and before the sealing of these presents by
A. L. Whitmore Trustee for Lizzie L. Laval of Greenville, S. C., Carolina.
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. L. Whitmore, Trustee all that piece of land
situate lying and being in the County of Greenville in the State of
South Carolina near the corporate limits of the City of Greenville being
lot #7 of a subdivision of land made by H. A. Hudson dated June
20, 1905, having the following metes and bounds, courses and distances
to wit beginning at an iron pin South west corner of Easley Bridge
road and Poplar Avenue, thence along the Easley Bridge road S. 45°
W. Sixty feet to an iron pin corner of Lot #8, thence S 40° E. 190 feet to
an iron pin thence N 45° E. sixty feet to an iron pin Poplar Avenue,
thence along said Avenue N. 40° W. 190 feet to the beginning corner
containing 11,400 square feet, more or less being a portion of a tract
of land conveyed by J. M. Enright to Henry H. Townes, said Henry H. Townes having conveyed by separate deed to the remaining grantors
certain certain interest this deed conveys complete and absolute title
in fee simple to said lot here in described in trust for the sole use

and forever defend all and singular, the said premises unto the said A. L. Whitmore, Trustee
her successors.

Heirs and Assigns, against ourselves, and our Heirs, and against every
person whomsoever lawfully claiming or to claim the same or any part thereof.
