(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Martha Jane Edwards for and during the term of her natural life, and from and immediately after her death to the said Perry Edwards and Robert J. Edwards Trustee of and for the said James M. Edwards, the survivor of them their Heirs and assigns, all that piece, parcel and tract of land situate, lying and being in Greenville County in the State aforesaid on Bradley Creek, branch waters of Moore River and having the following lines and boundaries to wit; beginning at a post oak 3x3 feet near my dwelling house and running thence S 20° 15' 54" chains to a Spanish oak 3x one; thence S 57° 04' 60" chains to a stone 3x one in ditch; thence N 48° E 10.25" chains to a post oak 3x one; thence N 35° 52' 3" chains to a post oak 3x one on M. Carter's line; thence with said line N 62° W 75° 00" chains to a stone 3x in place of a white oak gone; thence N 36° W 40° 00" to a stone 3x in place of a dogwood gone; thence N 73° W 9° 12" chains to a stone 3x; thence N 83° W 68° 00" chains to a stone on Rhad Green's line; thence S 23° E 28.50" chains to a stone 3x in place of a stake gone; thence N 63° E 22.65" chains to a stone 3x; thence S 43° E 28.74" chains to the beginning, containing three hundred and eighty acres more or less, and bounded by lands of Asa Green, Rhad Green and others;

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD all and singular the said premises before mentioned unto the said Martha Jane Edwards for and during the term of her natural life and after her death to the survivor of her heirs, trust (nevertheless) for a period of 15 years and thereafter to receive the rents, issue and profits thereof for the maintenance and support of the said James M. Edwards as long as he shall live, and to devise the same amongst his heirs, free from all taxes, with power And to let for期内, to hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Martha Jane Edwards for life and after her death unto the said Perry Edwards and Robert J.
