J. Stroud's lot. Thence S. 42.5 feet N. 45 feet to line of lot #2; thence along lot #2 N. 53.5 feet N. 51 feet to Duncan street, thence N. 23 feet N. 45 feet Duncan street to the beginning corner containing 4 1/4 acres square feet.
