Butler Hunt of the County of Greenville and also in consideration of the love and affection which I have for the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. Butler Hunt an undivided one-half interest in all that piece, parcel or lot of land

in Gantt Township, Greenville County, State of South Carolina, about seven miles from Greenville Court house on the Augusta Road and on branch waters of Reedy River, having the following metes and bounds; beginning on a Rock 3X; thence S. 70 W. 20.50 chains to dead R.O. 3X; thence E. 12.00 chains to a Black-oak 3X; thence S. 40 E. 25.00 chains to stone 3X; thence with Road line 17.00 chains to stone on the Augusta Road; thence N. 85 E. 15.00 chains to Pine 3X; thence E. 17.50 chains to R.O. Bush 3X; thence N. to a stone 3X; thence W. 43.50 chains; thence S. 42 W. 9.00 chains to a stone in field; thence S. 14 W. 16.00 to the beginning corner, containing One hundred and seventeen acres, more or less and being the same conveyed to me by T. And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said T. Butler Hunt, his

Heirs and Assigns, against me and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
