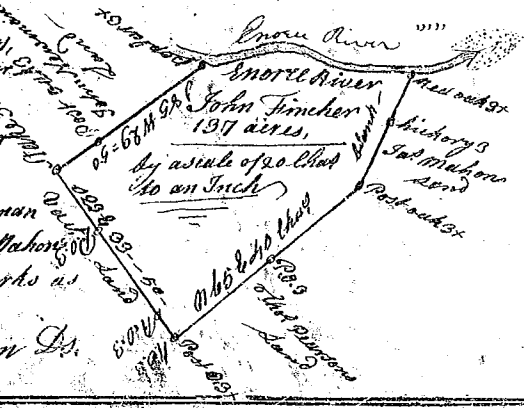
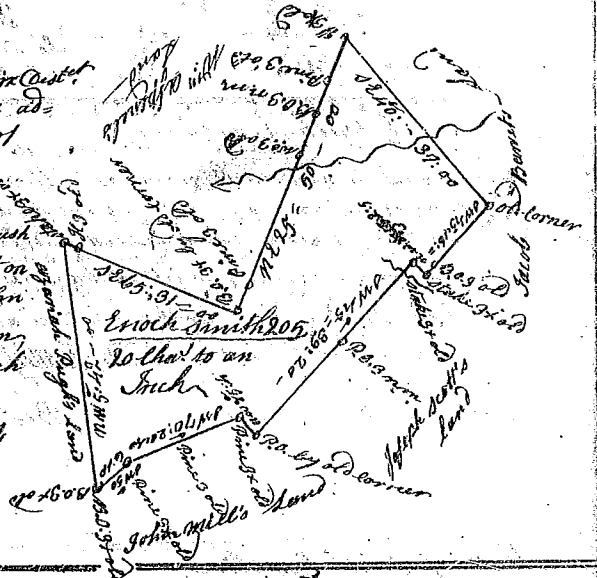


State of South Carolina, Ninety six District East of the ancient boundary line,

 measured and laid out unto John Fincher a tract containing four hundred acres of Land situate on the  
 south side of Tygar River on both sides of Fincher's branch, bounded N.E. by said Fincher's land  
 and Barnet Putman's Land, & by Ormel Fincher's Land, and hath such shape and Marks as the  
 above Plat represents, Surveyed the 1<sup>st</sup> April 1785, by Andrew Thomson Esq.

Recorded 5<sup>th</sup> May 1785,

 Pursuant to a warrant from John Thomas Commissioner of Locations dated the 1<sup>st</sup> day of April 1785, I have admeasur'd  
 and laid out unto John Fincher a tract of Land containing

 Enoree River, bounded SW on Land laid out for John Newman  
 & vacant vacant Land, NE on Thomas Pearson & James Mahone's  
 Land N by Enoree River, and hath such shape and Marks as  
 the above Plat represents, Surveyed the 1<sup>st</sup> April 1785,  
 Recorded the 5<sup>th</sup> May 1785, by W<sup>m</sup> Thomson Esq.

 below the ancient boundary line, on the waters of Cash  
 River, bounded on the NE on land of 20<sup>th</sup> apperell's part on  
 Jacob Barrett, S.E. part on Jacob Barrett, Jos. Scott and John  
 Mills S.W. on a parish Rugh, Part on Jos. Scott & part on  
 John Mills N.W. on William apperell, and hath such  
 and Marks as the above Plat represents,  
 Surveyed 29<sup>th</sup> Jan<sup>y</sup> 1785, Phil<sup>l</sup> Waters Esq.

 District (Below the ancient Boundary) on Beaverdam Creek  
 Waters of Saluda River, bounded on the S.W. by Caleb  
 Gilbert's Land, on the N.W. by land granted to Thomas Brooker,  
 all other sides on vacant Land, and hath such shape &  
 marks as the above plat represents, Surveyed the 8<sup>th</sup> Feb<sup>r</sup> 1785  
 Recorded the 6<sup>th</sup> of May 1785
