by and between Luther E. Guy

WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS PERPETUAL BUILDING AND LOAN ASSOCIATION in the sum of three thousand dollars (\$3,000.00) Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly, the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

That lot ^{attent} ^{part} ^{of} the sixth Ward of the City of Greenville, known and designated as lot no. thirty-seven (37) on plat ^{of} ^{land} ^{of} ^{Mrs} ^{F. E.} ^{Harris}, Augusta street property made by ^{Bill} ^{A.} ^{Heard}, dated October 22, 1913, and recorded in the office of the Register of Mesne Conveyances for said County and State in Plat Book "C", at page 261 and having according to said plat, the following metes and bounds, to-wit:-
Beginning at a stake on the north side of Harris street one hundred and fifty (150) feet from Augusta Street, on the north-east corner of the lot of land now or formerly belonging to Mrs Butler, and running thence along the line of her lot and along line of lot belonging to Mrs W. Logan N. 12° W. one hundred and thirty-four (134) feet to a stake on line of lot now or formerly belonging to A. E. Walker, thence along line of last mentioned lot N. 66 1/2° E. forty-seven (47) feet to a stake on line of lot no. 36; thence along line of last mentioned lot approximately S. 23 1/2° E. one hundred and thirty (130) feet to a stake on Harris street, thence along said street S. 66 1/2° W. seventy-five (75) feet to the beginning corner, this being the same lot of land conveyed to me the said Luther E. Guy, by W. K. Graham by Deed bearing date the 29th day of June, A. D. 1918, and recorded in said office in Deed Book no. 35, page 408, this mortgage being given for the purpose of erecting a dwelling upon said lot of land.
