WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS PERPETUAL BUILDING AND LOAN ASSOCIATION in the sum of ... Seven Thousand Dollars, money loaned this day, with interest thereon from this date at the rate of six

monthly, or the lesser period of three months, per cent. per annum, payable weekly, the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and the present does grant, bargain, sell and release unto the said party of the second part all that certain tract of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

all that piece of land of base, lying and being in Ward One, Greenville City, County and State aforesaid and having the following metes and bounds to-wit:-

Beginning at an iron pin on Stone Avenue, joint corner between lots nos. 14 and 15, and running thence N. 2-08' 186.8' E. to an iron pin in back line of lot No. 12 thence N. 84-19' 20.30' E. 28' 5" to an iron pin in the western line of lot No. 12 thence S. 2-26' W. 15' 4" to an iron pin, thence N. 84-19' 20.30' E. to an iron pin corner lots nos. 13 and 14 thence S. 2-26' W. 16' 9' 5" to an iron pin on Stone Avenue corner lots nos. 13 and 14, thence along Stone Avenue S. 83-17' W. 40 feet to the beginning corner. This lot being known and designated as lot no. 4, as shown by a plat of same made by R. E. Dalton Engineer during the month of April 1919.

This mortgage being a second mortgage being junior to a first mortgage executed by G. Walker Wright and Roy F. Hunt, to the Home Building and Loan association to secure the sum of Twenty-eight Hundred (\$2800) Dollars, dated July 23rd 1919 and recorded in R.M.C. office in Vol 76 - page 84.
