 Bargained, Sold and Released, and by these Presents Do Grant, Bargain, sell and release unto the said Citizens Building and Loan Association of Greer,  
 Greenville County, South Carolina, all that lot of land, in said State and County, in the city of Greer, on the .....  
 ..... side of ..... street.

All that certain piece, parcel or tract of land situate, lying and  
 being in the state and County aforesaid, Chick Springs, about two  
 miles from the town of Greer, on the south side of the National  
 Highway, being a part of the J. P. Taylor land and bounded by lands  
 of T. M. Bobo, Estate, J. B. Brown, R. B. Vaughn, Sandrum Vaughn  
 et al, and having the following metes and bounds, to-wit: Beginning  
 at a stake on the National Highway, T. M. Bobo corner, and running  
 thence S. 12 W. 615.5 feet to an iron pin on the Old Bancombe road  
 thence S. 10 E. 375 feet to a stake on J. B. Brown's line, thence with  
 said line S. 38 - 15 - W. 130 feet to a poplar and a stone corner, thence  
 or 10 W. 503.5 feet to a stake in the old Bancombe road R. B. Vaughn  
 corner, thence with said road as a line N. 57 - 23 W. 194 feet to a  
 stake Sandrum Vaughn corner, thence or 10 - 15 E. 543 feet, to the  
 National Highway; thence with the said highway as the line S. 80  
 E. 313 feet to the beginning corner, containing five 39/100 acre (5.2)  
 more or less and being the same tract of land conveyed to me by
