in the State aforesaid, SEND GREETING:

WHEREAS, *I* the said *C. P. Mills*.

in and by *my* certain Bond or Obligation of even date herewith stand firmly held and bound unto CITIZENS BUILDING AND LOAN ASSOCIATION of Greer, Greenville County, South Carolina, in the full sum of *Four Thousand Dollars*, conditioned for the payment of the monthly sum of *Sixty-six and 6/100* Dollars, on the *first Tuesday* *Fifth* of each and every month succeeding the date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS and also for *Tens Per Cent* attorney's fees, in case of suit or of collection by or through an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, that *I* the said *C. P. Mills*,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS to *me* *J. C. P. Mills* in hand, I have and truly paid by the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, at and before the setting and delivery of these presents, the receipt whereof is hereby acknowledged, the said *J. C. P. Mills* Have Granted, Bargained, Sold and Released, and by these Presents Do Grant, Bargain, sell and release unto the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, *that lot of land* in said State and County, in the city of Greer, on the *West* side of *Lime Street*.

Beginning at an iron pin on the West side of *Lime Street* at point 2,29 feet, in a southerly direction from the intersection of *Lime St.* with *Arlington Avenue* (*Grace St.*) at corner of lot #5, thence with line of lot #5 in a westerly direction 115 feet to an iron pin on line of lot #6; thence with line of lot #6 in a southwesterly direction 40 feet to an iron pin, joint corner of lots #6 and #7; thence S. 61° 30' E. 137.4 feet to an iron pin on *Lime Street*; thence with *Lime Street* N. 38° 90' feet to the beginning corner. This being known and designated as lot #7 on plat of property known as *Carrion Heights* prepared by *A. J. Bailey C. E.* in 1920, said plat is recorded in R. R. O. Office for Greenville County, Plat Book 3 Page 248, being the same lot conveyed to me by *R. D. Dobson* and to *R. D. Dobson* by *Allen R. Hawkins*.

Reservation is hereby made for an easement for Water and Sewerage line through lot #7 from Lot #6 to *Lime Street*, same being for lot #6,
