having the following metes and bounds, to-wit:— Beginning at a stake on south side of James Street, corner of lot #8, and runs thence with line of lot #8 S. 6-30 W. 221.4 feet to a stake on an alley; thence N. 76-30 W. 57.4 feet to a stake, corner of lot #6; thence with line of lot #6 N. 6-30 E. 21.8 feet to a stake on south side of James Street; thence with said street S. 45-8-60 feet to the beginning corner, and designated as lot #4 on a plat hereinafter referred to.
