CITIZENS BUILDING AND LOAN ASSOCIATION of Greer, Greenville County, South Carolina, in the full sum of  
*One Thousand Dollars*,  
conditioned for the payment of the monthly sum of *Sixty dollars & 7/10d* Dollars,  
on the *first Tuesday* of each and every month succeeding the  
date hereof, until each and every share in the said Association shall reach the value of ONE HUNDRED DOLLARS and also for  
*lawyer's fees, in case of suit or of collection by or through*  
an attorney, which, in addition to said debt, is hereby secured and made a lien on the premises, as in and by the said Bond and Condition thereof, reference  
being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, that *I* the said *El. W. T. Brookman*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN  
ASSOCIATION of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE  
DOLLARS to *me* to said *El. W. T. Brookman* in hand, well and truly paid by the said CITIZENS BUILDING AND LOAN ASSOCIATION of Greer, Greenville  
County, South Carolina, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged,

the said *El. W. T. Brookman* Have Granted,  
Bargained, Sold and Released, and by these Presents Do Grant, Bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION of Greer,  
Greenville County, South Carolina, all that *lot* of land, in said State and County, in the city of Greer, on the *South*  
*side of N. Merchant street*.

Beginning at a stake on Merchant street  
and running thence N. 2. 06 E. to a stake on line  
of lot #18; thence S. 80-30 W. 66.2 feet to a stake  
thence S. 80-14 W. 238.4 feet to a stake on said  
Merchant street; thence S. 88-03 E. 68 feet to  
the beginning corner. Being a portion of  
lot #17 and lot #19 on a plat of land called  
Merchant Place.

Also all that other lot of land situate  
lying and being in the State and county  
aforesaid on the south side of Merchant  
street in Greer. Beginning at a pin on  
Merchant street and running thence  
S. 0-14 E. 347.2 feet to a pin; thence with  
the line of a branch N. 58-18 W. 151 feet to  
a stake on back of branch; thence N.  
0-52 E. 272 feet to street. thence with  
Merchant street S. 89-01 E. to the beginning  
corner, being lot #16 on map furnished  
by H. Alvin Jones of the Merchant place  
and being known as the Merchant Home.
