NOW, KNOW ALL MEN That *I* the said *G. W. Johnson* in consideration of the said debt and sum of money aforesaid and for the better securing the payment thereof to the said PIEDMONT SAVINGS AND TRUST COMPANY, according to the condition of the said note or obligation, and also in consideration of the further sum of FIVE DOLLARS, to *me* the said *G. W. Johnson*

in hand well and truly paid by the said PIEDMONT SAVINGS AND TRUST COMPANY, at and before the sealing and delivery of these Presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and, by these presents, do grant, bargain, sell and release unto the said PIEDMONT SAVINGS AND TRUST COMPANY, all that tract or parcel of land, situated in County of *Greenville* State of South Carolina, and described as follows:

All that piece, parcel or tract of land, situate lying and being in the state and County aforesaid in the head of South Tiger River and in Highland Township and has the following metes and bounds to wit:

Beginning at a stake in the state road, thence N. 69° E. 5.00 chains to a stake in head of Tiger River; thence with said river as a line 30.67 chains to a stake in said River; thence S. 85° W. 5.10 chains to a stake in state road; thence along said road as a line 30.20 chains to the beginning corner, containing sixteen (16) acres more or less.

Also all that other piece, parcel or tract of land adjoining the above described tract and having the following metes and bounds to wit:

Beginning at a stake in the head of Tiger River, thence N. 55° E. 33.50 chains across branch to poplar; thence N. 21° W. 21.03 chains to a large N. O.; thence N. 23° W. 8.50 chains to a stake; thence S. 43° W. 19.48 chains to a stake; thence 13 1/2° E. 18.69 chains to a pine; thence S. 70 1/2° W. 7.70 chains to a stake; thence S. 85° W. 2.75 chains to a stake in head of Tiger River; thence with said head of Tiger River 10.65 chains to the beginning corner corner; containing sixty six (66) acres more or less.
