Situate, lying and being in the city of Greenville on the East side of West Washington Street, being known and designated as lot No. 5, and having the following limits and bounds, according to a plat made by C. M. Furrman Jr. dated April 15 1920, and recorded in Plat Book "E" Page 240 R.M.C. Office for Greenville County.

Beginning on West Washington street at the joint corners of lots 5 & 6, running thence N. 41-40 E. 75 feet to an iron pin on a 10 foot alley, thence with said alley S. 48-50 E. 18 feet to an iron pin, corner of lot No. 4; thence S. 41-40 W. 75 feet to an iron pin on West Washington Street; thence with said street N. 48-50 W. 18 feet to the beginning corner, and being the same lot conveyed to us by George W.
