and if unpaid when due to bear interest at same rate as principal until paid, and I..... have further

promised and agreed to pay ten per cent. of the whole amount due for attorney's fees, if said note..... be collected by an attorney or through legal proceedings of any

kind before suit being brought, and will more fully appear:

NOW, KNOW ALL MEN That I..... the said.....

securing the payment thereof according to the terms of the said note..... and also in consideration of the further sum of Three Dollars (\$3.00).....

in and well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained and

released, and by these presents do grant, bargain, sell and release unto the said.....

all that piece, parcel, tract or lot of land situated in.....

Township, Greenville County, State of South Carolina,

Situate, lying and being in the Township,

County and State aforesaid containing 31.80 acres

more or less, and having the following metes and

bounds, to wit:

Beginning at a stake on corner of tract no. 2, and running thence N. 15 E. 1136 feet to a stone, thence N. 39 - 30 W. 1293 feet to a stone, thence S. 80 W. 1100 feet to a stake, corner Tract no. 4; thence along Tract no. 4 S. 0 - 30 E. 1123 feet to a stake, corner tracts nos. 2, 3 and 4; thence along line of Tract no. 2 N. 89 - 15 W. 964 feet to the beginning corner, less a twenty feet driveway along the line between Tracts nos. 1 and 2 which ft is agreed and understood is to be reserved by F. L. Rogers.
