in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. L. Garrett,

all that piece, parcel, tract or lot of land situated in Greenville

Township, Greenville County, State of South Carolina,

In the first Ward, City of Greenville, having the following metes and bounds: Beginning at a stake, on the East side of Lloyd Street two hundred six (206) feet, six (6) inches from the intersection of Pinekelly Street and running thence with the East side of Lloyd Street South 55-38 West fifty-six (56) feet, six (6) inches, to an iron pin thence South 52-42 East ninety-four (94) feet to a point on Bruns' formerly Hobbs line, thence with Bruns' line North 49-45 East twenty-six (26) feet, two (2) inches, to a stake on Montgomery's formerly Hammond line, thence with Montgomery's line North 33-54 West eighty-six (86) feet, six (6) inches, where or less, to the beginning corner on Lloyd Street.
