at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

William Goldsmith, General Agent, his successors and assigns all that lot of land situate near Judson Mills, County and State aforesaid, known as lot No. 11 as shown on plat recorded in Plat Book E, page 214 Beginning at an iron pin on the south side of Heatherly Drive, 80 feet east of Judson Road, and corner of lot 12, and runs thence with line of said lot 180 feet in a southerly direction to an iron pin which is 40 feet in a S. 64. 42 E. direction from Judson Road, thence with line of lot 13 S. 64. 42 E. 46. 7 feet to iron pin corner of lot 10; thence with line of that lot in a northerly direction 185 feet to iron pin on Heatherly Drive; thence with Heatherly Drive N. 69. 26 W. 62. 6 feet to the beginning corner being the same land conveyed to me by J. C. Heatherly by deed dated the 10th day of April, 1920 and recorded in Vol. 58, page 57.

Also that other lot of land adjoining the above and being known as Lot No. 10 on said plat, Beginning at a point on the south side of Heatherly Drive, corner of lot 11 (which is 142. 6 feet from Judson Road) and runs thence with line of said lot 185 feet, more or less to an iron pin in line of lot 13; thence with line of said lot S. 64. 42 E. 46. 7 feet to iron pin corner of lot 9; thence with line of said lot 190 feet, more or less, to iron pin on Heatherly Drive; thence with said Drive N. 69. 26 W. 62. 6 feet to the beginning corner, being the same land conveyed to me by J.
