with interest from date
 at the rate of eight per centum per annum until paid; interest to be computed and paid semi annually,
 and if unpaid when due to bear interest at same rate as principal until paid; and I have further
 promised and agreed to pay ten per cent. of the whole amount due for attorney's fees, if said note be collected by an attorney or through legal pro-
 ceedings of any kind, reference being made to the note and will more fully appear.
 NOW, KNOW ALL MEN THAT I, THE DEBT HEREIN SECURED IS PAID IN FULL AND THE LIEN OF THIS INSTRUMENT IS SATISFIED, THIS 19TH DAY OF October 1928

 In consideration of the said debt and sum of money aforesaid, and for the better
 securing the payment thereof according to the terms of the said note, and also in consideration of the further sum of Three Dollars to me
 in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold
 and released, and by these presents do grant, bargain, sell and release unto the said
 all that piece, parcel, tract or lot of land situated in

Township, Greenville County, State of South Carolina,

Thomas J. Charles all the right, title and interest
 of Drayton M. Smith in and to the real estate de-
 vised by E. S. Smith to Drayton M. Smith and also
 all such interest and claim to homestead in
 the following described premises in Austin
 Township, Greenville County, State of South
 Carolina about seven miles from Greenville
 Court House, having the following metes and
 bounds according to plat made by W. A.
 Hudson bearing date January 24, 1879 to wit
 Beginning at stake 3Xom on Southwest
 side of road from Greenville to Laurens
 and running thence S. 41 $\frac{1}{2}$ W. 42 chains to
 stone 3Xom; thence S. 57 $\frac{1}{2}$ E. 9.00 chains to
 stone 3Xom; thence S. 30 W. 34.30 to stone 3Xom
 thence S. 66 $\frac{3}{4}$ E. 10.80 chains to stone 3Xom
 thence N 4 $\frac{1}{2}$ E. 58.50 chains to stake on South
 side of Laurens Road, thence along said road
 N. 12 W. 3.50 chains to hind in said road, thence
 along said road N 20 $\frac{3}{4}$ W. 25.00 chains to be-
 ginning corner, containing 134 acres, more or
 less, and being the same tract of land con-
 veyed to E. S. Smith by Josiah Bramlett by
 deed November 28, 1884, recorded in Book
 N 21, page 449 but from said boundaries there
 was conveyed by E. S. Smith two small tracts
 three acres to Drivine Baldwin and one acre
 to George Johnson by deed recd. page 494,
 leaving 130 acres covered by this mortgage.
