 even date with these presents, *W. H. Hedges and John A. Hedges* in the full and just sum of *One hundred Dollars, to be paid April 1st, 1926* note..... in writing, of well and truly indebted to *W. H. Hedges and John A. Hedges (\$7500.00)*

with interest thereon, from *March* at the rate of *8* per cent. per annum to be computed and paid *semi-annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note..... to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *Five dollars* besides all costs and expenses of collection, to be added to the amount due on said note..... to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note..... reference being thereunto had, as will more fully appear.

Hedges and John A. Hedges* according to the terms of the said note....., and also in consideration of the further sum of Three Dollars, to *me*, the said *P. J. Cranes*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *W. H. Hedges and John A. Hedges*,

All that piece parcel or lot of land in Greenville Township, Greenville County, State aforesaid, in Ward six of the City of Greenville and having the following metes and bounds: To wit: Beginning at an iron pin on McDaniel Avenue 240 $\frac{1}{3}$ feet from Cleveland Street, South and running thence along McDaniel Avenue S. 85 E. 330 feet to a pin on McDaniel Avenue, thence along McDaniel Avenue N. 3 E. 330 feet to a pin on McDaniel Avenue S. 3 W. 330 feet to the beginning corner.

Also all that certain lot containing the *one acre* described, lot having the following boundaries: Beginning at an iron corner of the lot described, and running thence along the wood line S. 85 E. 330 feet to the corner of McDaniel Avenue N. 3 E. 330 feet, thence along McDaniel Avenue N. 3 E. 330 feet to the beginning corner.
