 ten per cent besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, in the sum to be placed in the hands of an attorney for collection, or if said debt, or  
 any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,

 1st. All those two certain tracts of land, in Fair  
 view Township, County and State aforesaid known and  
 designated as tracts No 1 and No 3, of the estate  
 of J. D. Richardson, deceased, and containing 131  
 and 119 $\frac{1}{4}$  acres, respectively, being the same two  
 tracts of land conveyed to me by E. Inman,  
 Master, by deed dated Nov 19, 1918, recorded in  
 the office of R. M. C. for Greenville County in Vol  
 52 page 254.

2nd. All that certain tract of land in said Town  
 ship, County and State, on the branches of Rock  
 Creek waters of Reedy River, containing 498 acres,
