NOW, KNOW ALL MEN, That I, J. D. Robins, the said,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note, and also in consideration of the further sum of Three Dollars to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said J. A. Roe

all that piece, parcel, tract or lot of land situated in Greenville Township, Greenville County, State of South Carolina,

fronting the lot no. 5 of Block E, Melrose Land Company as shown on plat recorded in plat Book A, Page 157 of fronting 50 feet on Melrose Avenue being the same conveyed to J. D. Robins by F. S. Miller, et al. by deed dated August 24, 1929, recorded in Book 104, Page 182.

Also that other lot of land in Townships, County and State aforesaid, being part of the lands of Melrose Land Company as shown on plat above referred to, known as lot no. 9 of Block E, fronting fifty feet on Melrose Avenue, being the same conveyed to J.
