

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, A. D. L. Barksdale

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said A. D. L. Barksdale in and by my certain note or obligation, bearing the 2nd day of July 1924

I and indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Thirty-seven Hundred & no/100 (\$37.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 2nd day of July A. D. 1924, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said A. D. L. Barksdale shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of July 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Fifty-one & 67/100 (\$51.67) Dollars, (\$37.00) Dollars, being the regular monthly installment payable on the Thirty-seven (37) Shares of Stock, and Twenty-four & 67/100 (\$24.67)

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Fifty-six & 73/100 (\$56.73) Dollars, (\$37.00) Dollars, being the regular monthly payment on said stock and Twenty & 73/100 (\$20.73) Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Fifty-one & 80/100 (\$51.80) Dollars, (\$37.00) Dollars, being the regular monthly payment on said stock and Twelve & 80/100 (\$12.80) Dollars, being the monthly interest on balance due);

for the next twenty months pay the sum of Forty-six & 87/100 (\$46.87) Dollars, (\$37.00) Dollars, being the monthly payment on said shares of stock and Nine & 87/100 (\$9.87) Dollars, being the monthly interest on balance due);

for the next twenty months pay the sum of Forty-one & 93/100 (\$41.93) Dollars, (\$37.00) Dollars, being the monthly payment on said shares of stock and Four & 93/100 (\$4.93) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 37 shares of stock and the certificate thereof, the amount at such time paid shares by I to be credited as a payment upon the advance or loan made I, the said A. D. L. Barksdale

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against I the said A. D. L. Barksdale in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being hereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said A. D. L. Barksdale in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said A. D. L. Barksdale

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville. Beginning on the west side of Rowley Street 175 feet from the corner of Rowley Street and Stone Avenue; thence with Rowley Street S. 20-19 W. 50 feet and 8-1/2 inches; thence N. 69-29 W. 111 feet and 2-1/2 inches; thence N. 73 W. 111 feet and 9 inches; thence N. 19 E. 55 feet and 8 inches; thence S. 73 E. 111 feet and 9 inches; thence N. 20-19 E. 4 feet and 7-1/2 inches; thence S. 69-29 E. 55 feet and 2-1/2 inches; thence S. 20-19 W. 2 feet and 3-3/4 inches; thence Southeasterly 55 feet to beginning corner, and being the same lot conveyed to me by A.
