of Greenville, in the County of Greenville and the State of South Carolina, send Greenvill:

WHEREAS, *That I Anna E. Butler*, the said *Anna E. Butler*, day of *January*, 1926,
 in and by *my* certain note or obligation, bearing the date *January*, 1926, day of *January*, 1926,
 indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
 duly incorporated under the laws of such State), in the sum of *Nine Hundred Dollars, no 100 & 900.00* Dollars,
 with interest thereon at the rate of eight per centum per annum, payable monthly, from the 1st day of *January*, A. D. 1926,
 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
 the said *Anna E. Butler* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *January*,
 1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *\$15.00* Dollars,
 being the regular monthly installment payable on the *shares* (*9*) Shares of Stock and *16.60* Dollars,
 Dollars being the monthly interest on the advance or loan until there have been paid monthly monthly payments, and shall for the next twenty months pay the sum of *1.30* Dollars, *1.30* Dollars,
 Dollars being the regular monthly payment on said stock and *.80* Dollars, *.80* Dollars, being the monthly interest on balance due;
 for the next twenty months the sum of *12.60* Dollars, *12.60* Dollars, being the regular monthly payment on said stock and *.30* Dollars, *.30* Dollars, being the monthly interest on balance due;
 Dollars, *1.00* Dollars, being the monthly payment on said shares of stock and *1.00* Dollars, *1.00* Dollars, being the monthly payment on said shares of stock and *.20* Dollars, *.20* Dollars, being the monthly interest on balance due.)
 Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *shares* (*9*) shares of stock and the certificate thereof, the amount at such time paid shares by *me* to be credited as a payment upon the advance or loan made, the said *Anna E.  and shall pay or cause to be paid all fines which may be duly imposed upon or charged against *me* the said *Anna E. Butler* in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereto had will more fully appear.

NOW KNOW ALL MEN, That *the said Anna E. Butler*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *the said Anna E. Butler*, in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

I bear the city of Greenville being a part of what is known as City View place of which is recorded in plat book A pages 460 and 461 and being known and designated as lot no 54 in block A on said plat and having a frontage of fifty (50) feet on the east side of Henderson Street and running back in parallel lines 130 feet. Also

All that piece parcel or strip of land situate lying and being in Greenville County, State of South Carolina, to wit, one miles west of Greenville, known as "City View". Beginning at a Stake 130 feet from the northeast corner of Summerville Street, same being on Henderson Street, joint corners of lots nos. 502, 503 and 54, and running thence S. 84° 12' E. 130 feet to a Stake corner of lots nos. 53 and 55, thence S. 30 W. 20 feet to a Stake thence N. 89° 12' E. 130 feet to a Stake on Henderson Street, thence N. 30 E. 200 feet to the beginning corner and being a portion of lot no. 53, according to a plat made by W. H. Oldham Surveyor, no. all as stated was conveyed to me by C. G. Lockett by deed dated December 31st 1926 to be recorded.
