

## THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

*That I. A. Murdoch and Jessie L. Murdoch*  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *I. A. Murdoch and Jessie L. Murdoch*, the said..., in and by *Decr* certain note or obligation, bearing the day of *January* 1926

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *One hundred and twenty-five thousand (\$2500.00) Dollars*, with interest thereon at the rate of eight per centum per annum, payable monthly from the 6th day of January A. D. 1926, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

*We* the said *I. A. Murdoch and Jessie L. being the regular monthly installment payable on the *Twenty-five (\$25.) Shares of Stock and* *1.67* Dollars, being the monthly interest on the advance or loan until there have been paid *29.17* monthly payments, and shall for the next *20* months pay the sum of *95.83* Dollars, *12.50*

Murdoch*, in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company all that tract of parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

*In the 8th ward of the City of Greenville and*  
*having the following lines and bounds to wit:*  
*Beginning at a point on the east side of Hudson*  
*Street, about of and fifty (50) feet distance from*  
*Mrs. C. A. Johnson's north west corner and running thence*  
*in a southerly direction parallel with said 50 feet*  
*from Johnson's northern line ninety seven (.97) feet*  
*to line of Mrs. S. H. Ellis, thence with her line*  
*in a northerly direction 56 feet, more or less to*  
*Johns Street, thence with Johns Street in a northwesterly*
