

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mamie Green  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Mamie Green  
in and by My certain note or obligation, bearing the 13th day of March 1926

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Twelve Hundred (\$1200.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 23 day of March A. D. 1926, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said Mamie Green shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of April 1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of \$20.00

Dollars, (\$12.00 Dollars, being the regular monthly installment payable on the Twelve (12) Shares of Stock and \$8.00 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of \$18.40 Dollars,

being the regular monthly payment on said stock and \$6.80 Dollars, being the monthly interest on balance due); for the next twenty months the sum of \$16.80 Dollars,

(\$12.00 Dollars, being the regular monthly payment on said stock and \$4.80 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$15.20 Dollars,

(\$12.00 Dollars, being the monthly payment on said shares of stock and \$3.20 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$13.60 Dollars,

(\$12.00 Dollars, being the monthly payment on said shares of stock and \$1.60 Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said

shares of stock and the certificate thereon, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made by the said Mamie Green

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against I the said Mamie Green in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Mamie Green in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Mamie Green

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

all that certain piece parcel or lot of land situate, lying and being in the County and State aforesaid near the Earley Bridge Road, about two (2) miles from the Court House, and being known as Lot #49 of the subdivision of J. R. West, said survey having been made by A. S. Bedell, a plat of which is recorded in Plat Book "C" Page 190, R.M.C. Office for Greenville County. Said lots fronts West Street 60 feet and has a depth on side adjoining Lot No. 48-150.4 feet and depth of 179.1 feet on the other side with a frontage of 56.6 feet in the rear, and being the same lot conveyed to me by C. S. Pender by deed dated July 21, 1925, and recorded in Deed Book 105, Page 425 R.M.C. Office for Greenville County
