at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said J. W. Locker, all that piece, parcel

or lot of land, more or less, lying and situated in the Township of Fairview and Austin Townships, Greenville County, State of South Carolina, having the following number and boundaries, corners and distances, to wit: Beginning at an iron pin, corner of truck of Harris & McAllister and J.R. Cox, and running thence N. 85° 40' E. 37+50 to stone, corner of corner of Harris & McAllister and Moore's - thence N. 31-30 W. 16-91 along line of Moore lands to iron pin, - thence S. 76-30 W. 31-43 to iron pin - thence S. 15-30 E. 10-00 along line of border of J.R. Cox to the beginning point, containing forty four and 18/100 (44.18) acres, more or less, - save and except a certain tract containing 1 acre, more or less, on the northerly side of the tract herein conveyed, which has been conveyed away and which is described more fully as follows:

Beginning at a point in the center of the S.E.W.C. Railroad, and running thence N. 6 $\frac{1}{2}$ E. 3.24 to iron pin at center of said railroad, thence leaving said railroad and running thence S. 76-30 W. 3.64 to iron pin, thence S. 6 $\frac{1}{2}$ W. 3.24 to iron pin, thence N. 76 E. 3.64 to the beginning corner also save and except a small strip of land on the west side of the one acre tract above described, which has been conveyed away and which is described as follows: Beginning at a point at the south west corner of the one acre tract above described, and running thence N. 6 $\frac{1}{2}$ E. 3.24 to iron pin, thence S. 76-30 W. 3.64 to iron pin, thence S. 6 $\frac{1}{2}$ W. 3.24 to iron pin, thence N. 76 E. 3.64 to the beginning corner, being the same land conveyed to me by Marshall West and Harris & McAllister by deed dated Oct 14th, 1920, recorded in office of H.
