Office of Greenville County in Plat Book "F" page 141 and having the following metes and bounds to wit: Beginning at an iron pin on the South side of Blasingame Street 399 feet East of the Augusta Road and at corner of lot no. 8, running thence S 26-30 E. 199.1 feet to an iron pin on line of J. A.
