WHEREAS, I, the said Lenora B. Haselwood, and Lewis H. Haselwood, SEND GREETING:

in and by our certain Note or obligation bearing even date herewith, stand indebted unto THE PRUDENTIAL INSURANCE COMPANY OF AMERICA in the full and just principal sum of Thirty-eight hundred and no^o 100 Dollars (\$3,800.00) to be paid in

years from date, at the dates and in the amounts as follows, namely:

with interest thereon from date hereof, at the rate set forth in said note the principal of said note together with interest being due and payable in monthly instalments as follows:

Beginning on the first day of October, 1938, and on the first day of each month thereafter the sum of Twenty-five and 08/100 (\$25.08) Dollars and the balance of said principal sum due and payable on the first day of September, 1958. All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the West side of Hilton Street in the City of Greenville, County of Greenville, State of South Carolina known and designated as part of Lots 28 and 30 of Section B, in plat of Stone Land Company recorded in the R. O. C. Office for Greenville County, South Carolina, in Plat Book A, at pages 337-345, and having, according to survey made by R. E. Dalton, Engineer, August 18, 1938, the following metes and bounds, to-wit:

Beginning at a concrete post on the West side of Hilton Street, said post being 70 feet North from the Northwest corner of intersection of West Broad Street and Hilton Street and running thence N. 83° 17' 31. 148 feet to a stake; thence N. 1° 41' E. 70 feet to a stake; thence S. 83° 17' E. 148 feet to an iron pin on the West side of Hilton Street; thence with the West side of Hilton Street S. 1° 41' N. 70 feet to the beginning corner.

This is the identical property conveyed to the mortgagor herein by deed of H. P. Myers dated September 3rd, 1938, and recorded in the R. O. C. Office for Greenville County, South Carolina, in Deeds Volume 205, page 356.
