TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, *I, Nena McSwain Carpenter, and William McNeill Carpenter*, SEND GREETING:  
 in and by *our* certain Note or obligation bearing even date herewith, stand indebted unto THE PRUDENTIAL INSURANCE COMPANY OF AMERICA in the full and just principal sum of *Forty-nine Hundred & no/100 Dollars (\$4,900.00)* to be paid in *years from date, at the dates and in the amounts as follows, namely:*

*with interest thereon from the date hereof, at the rate set forth in said note, the principal of said note together with interest being due and payable in monthly instalments as follows:*

*Beginning on the first day of October, 1939, and on the first day of each month thereafter the sum of Thirty-six & 16/100 (\$36.16) Dollars and the balance of said principal sum due and payable on the first day of May 1956. The aforesaid monthly payments of Thirty-six & 16/100 (\$36.16) Dollars each are to be applied first to interest at the rate set forth in said note in their principal sum of Forty-nine Hundred & no/100 (\$4,900.00) Dollars, or so much as shall from time to time remain unpaid, and the balance of each monthly instalment shall be applied on account of principal.*

*Said note provides that past due principal and/or interest shall and with interest from date at the rate of* *per cent per annum, payable* *annually on the*

*day of* *and* *of each year, past due principal and interest to bear interest at the rate of seven (7%) per cent per annum, as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee.*

*All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the South side of Hanner Street, near the City of Greenville, in the County of Greenville, State of South Carolina, known and designated as Lot No. 25 on plat of Stase Lothran property, made by Dalton & Neves, Engineers, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book 34, at page 163, and having, according to said plat and a recent survey made by R. E. REED, on August 26, 1939, the following metes and bounds:*

*Beginning at an iron pin on the South side of Hanner Street, which iron pin is 265 feet off the corner of the intersection of Hanner Street and McDaniel Avenue, and running thence with the South side of Hanner Street S. 81° 15' E. 65 feet to an iron pin; thence with the line of Lot No. 26, S. 9° 35' W. 162.5 feet to an iron pin; thence with the line of Lot No. 28, N. 81° 15' W. 65 feet to an iron pin; thence with the line of Lot No. 24, N. 9° 35' E. 162.5 feet to an iron pin on the South side of Hanner Street, the beginning corner.*
