money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly, the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to wit:

On Whitehall Extension, just outside the City of Greenville, and having the following lines and bounds, to wit: Beginning at a stake on Whitehall Street Extension, corner of John Morris' lot, and running thence along Whitehall Street Extension in a Westerly direction 50 feet to a stake; thence in a Westerly direction 110 feet to a stake; thence in a Southerly direction 40 feet to a stake, Morris' line, thence along line of Morris' lot in an Easterly direction 110 feet to the beginning corner.

Also, all that piece, parcel or strip of land in Greenville Township, near Whitehall Extension, just outside the City of Greenville, and having the following lines and bounds, to wit: Beginning at a stake on line between the lots conveyed by J. W. Tamm to N. S. Wilburn and J. F. Gresham by deed dated February 26, 1924, 38 feet west of Whitehall Extension, and running thence with the original line between said lots in a Westerly direction 762 feet to stake 40 feet from John Morris' lot; thence in a Northerly direction 10 feet to stake; thence in an Easterly direction 72 feet, more or less, to the beginning corner.
