WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of

Five hundred and twenty dollars

money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly, the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to wit:

Just outside the city of Greenville, known as Lot 110, 51 of Crescent Terrace as shown on plat recorded in plat book 103, page 137, having their defining lines and bounds beginning at a stake on the north side of James Avenue, joint corner lots 50 and 51, running thence with said street S. 0-50 20.70 feet to stake corner of Lot 52; thence along line of that lot 169.7 feet to stake; thence S. 11-16-08 W. 72.5 feet to stake, corner lot 50; thence along line of that lot S. 24-10 E. 190.5 feet to beginning, being the same conveyed to Augusta Road Baptist Church by C. J. Gentry by deed dated July 21, 1925, recorded in book 103, page 195.

This Mortgage is given pursuant to authority contained in a resolution adopted by Augusta Road Baptist Church November 15, 1931.
