described premises to comply with the requirements of any Department of the City of Greenville, South Caroling within thirty days after notice of such requirement shall have been given to the then owner of said premises by the said Mortgage, or if the said premises are not maintained in as good a state of repair as they were at the date of this mortgage, reasonable depreciation alone excepted, and within sixty days after notice by the Mortgagee to the owner to repair said premises, the owner shall fail to put the said premises in as good a state of repair as they were at the date of this mortgage, reasonable depreciation alone excepted.
