WHEREAS I, the said Henry H. Woods

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of SIX THOUSAND, SEVEN HUNDRED AND NO/100

(\$ 6,700.00) Dollars, with interest at the rate of four (4%) per centum per annum, to be repaid in instalments of FORTY-TWO AND NO/100

(\$ 42.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, Henry H. Woods, the said

C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the southeast side of the Old Spartanburg Road (also known as the Camp Road), and being known and designated as the northeastern portion of Lot No. 10, of Block B. of a subdivision known as Northgate, as shown on a revised plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book M, at page 13, and being more particularly described as follows:-

"BEGINNING at an iron pin on the southeast side of the Old Spartanburg Road at the corner of Block D, and running thence along the line of said Block D in a southeasterly direction 100.3 feet to an iron pin at the rear corner of Lot No. 9, of Block B; thence along the rear line of said Lot No. 9, in a southwesterly direction 126.35 feet to an iron pin in the rear line of said lot, which point is 66.35 feet Northeast of the rear corner of Lots Nos. 9, 10 and 11; thence on a line through Lot No. 10, of Block B, in a northwesterly direction, 151.4 feet to an iron pin on the southeast side of the Old Spartanburg Road, which point is 72.5 feet northeast of the corner of Lots Nos. 10 and 11; thence along the southeast side of said Spartanburg Road, in a northeasterly direction, 62.5 feet to the beginning corner. Being the same lot of land conveyed to me by Paul J. Oeland and James S. Simpson, Jr., by deed of even date herewith, not yet recorded
