Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof. And the said mortgagor___ agree___ to insure and keep insured the houses and buildings on said lot in a sum not less than Five Thousand (\$5,000,00) Dollars in a company or companies satisfactory to the mortgagee from loss or damage by fire, and the sum of Five Thous - - (\$5,000.00) - Dollars from loss or damage by tornado, and assign and deliver the policies of insurance to the said mortgagee, and that in the event the mortgagor__ shall at any time fail to do so, then the mortgagee may cause the same to be insured and reimburse itself for the premium, with interest, under this mortgage; or the mortgagee at its election may on such failure declare the debt due and institute foreclosure proceedings.
