until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said C. P. Hammond, his heirs and assigns:-

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, about three miles Northeast from Greenville Court House, on the East side of Greenville-Greer National Highway, being known and designated as Lot No. three(3) on Map No. 1 of the Estate of Sellie W. Raines, made by W. J. Riddle, Surveyor, June 1947, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "R", at page 25, and having, according to said plat, the following metes and bounds, to-wit:-

BEGINNING at a point 161.5 feet East of Camp Road, and running thence S. 60-18 E. one hundred and seventy-five(175) feet to a stake; thence S. 28-32 W. seventy-five(75) feet to corner of Lot No. 4; thence along the dividing line between said Lots Nos. 3 and 4, N. 60-18 W. one hundred and seventy-five (175) feet to a point in line of Lot No. two(2); thence along line of Lot No. 2, N. 28-32 E. seventy-five (75) feet to the beginning corner; being a portion of the property conveyed to Sellie W. Raines by J. A. Kinion by deed dated March 6, 1939, and recorded in the RMC Office for Greenville County, South Carolina, in Deed Book No. 209, at page 181; and being the identical property conveyed to me by Samuel Gary Raines, et al., by deed dated August 16th, 1947, and recorded in the RMC Office for Greenville County, S.C., in Deed Book No. 318, at page 130.
