LOT NO. 1: All that certain piece, parcel or lot of land, situated lying and being on the North side of the Cedar Lane Road, near the City of Greenville, and in the County of Greenville, State of South Carolina, and being a part of the Riverside Farms. shown as Lot No. four (4) on plat of property of Knox L. Haynsworth, Trustee, made by Dalton & Neves, Engineers, May, 1941, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "L", at page 177, and having, according to said plat, the following metes and bounds, to-wit:
