A. Moseley, made by Dalton & Neves in June 1940, recorded in Plat Book "J" at Page 239, and described as follows:

"BEGINNING at a stake on the Southeastern side of Charles Street, corner of lot No. 30, and running thence with line of said lot, S. 46-45 E. 168 feet to a stake on the right-of-way of the F. & N.
