and just sum of NINE THOUSAND AND NO/100 (\$. 9,000.00 .)
Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of
SIXTY-EIGHT.AND.NO/1.00
NOW KNOW ALL MEN, That, the saidLocal Home Builders, Inc
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the
said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms
of said note, and also in consideration of the further sum of Three Dollars to, the said
in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:
"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon,
situate, lying and being in the State of South Carolina, County of Greenville, Greenville. Township, now within the corporate limits of the City of Greenville, being known and designated as Lot No. 22 of a subdivision known as Forest Heights, according to a plat thereof prepared by Dalton and Neves, Engineers in June, 1946 and recorded in the R. M. C. office for Greenville County in Plat Book P, at page 71, and having, according to said plat, the following metes and bounds, to-wit:
"BEGINNING at an iron pin on the Southwest side of Longview Terrace at the joint front corner of Lots Nos. 22 and 23, and running thence with the line of Lot No. 23, S. 20-44 W. 151.4 feet to an iron pin; thence with the rear line of Lots Nos. 7 and 8, S. 65-45 E. 70.1 feet to an iron pin at the rear corner of Lot No. 21; thence with the line of Lot No. 21, N. 20-44 E. 155.8 feet to an iron pin on the Southwest side of Longview Terrace; thence with the Southwest side of Longview Terrace,

N. 69-16 W. 70 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the property conveyed to said corporation by Walter Heath by his deed dated April 24, 1950 and recorded in the R. M. C. office for Greenville County in Deed Vol. 412, at page 467."
