Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation
organized and existing under the laws of South Carolina, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of Four Thousand and no/100
Dollars (\$ 4,000.00), with interest from date at the rate of four and one-fourth per centum
(4 1/4%) per annum until paid, said principal and interest being payable at the office of
C. Douglas Wilson & Co. in Greenville, S. C.
or at such other place as the holder of the note may designate in writing, in monthly installments of
Twenty-four and 80/100 Dollars (\$ 24.80),
commencing on the first day of October, 19 50, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of September, 19 70.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that certain piece, parcel or lot of land with the buildings and improvements
thereon, lying and being on the Easterly side of Florida Avenue, near the City of
Greenville, South Carolina, being shown as lot No. 5, Block "L", on the Map of High-
land Subdivision as recorded in the RMC Office for Greenville County, S. C., in Plat
Book "K", pages 50-51, said lot fronting 60 feet on the Easterly side of Florida Avenue
and having a depth of 284.3 feet on the Northerly side, a depth of 271.6 feet on the
Southerly side and being 61.35 feet across the rear.
