To All Whom These Presents May Concern:

SEND GREETING:

WHEREAS, I the said W. O. Lockaby

in and by my certain promissory note in writing of even date with these Presents, well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Twenty-five Hundred XXXXXXXXXXXXXXXX (\$ 2500.00) Dollars,

with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Forty XXXXXXXXXXXXXXXX (\$ 40.00) dollars

due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That I the said

W. O. Lockaby

, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, located near Pleasant View Baptist Church, on the West side of the Rutherford Road, being bounded on the North bylands of Steadman, on the East by the said road, on the South by lands formerly of Walter Smith Estate (now of Douglas E. Greer) and on the West by W. H. Langley, having the following courses and distances, to wit:-

BEGINNING on a stone, old corner, and joint corner of the Douglas E. Greer land, and runs thence with the Greer line N 41-30 E 341.5 feet to a nail and stopper in the center of the said Rutherford Road and on the Greer line and also the joint corner of the Manley Hughes tract; thence with the center of the said road N 20-15 W 858.5 feet to a nail and stopper in the center of the said road, joint corner of the Hughes tract and on the Steadman line; thence with the Steadman line S 13-20 W 445.5 feet to iron pin; thence a new line S 15-38 E 652 feet to the beginning corner, containing Four and Six Tenths (4.6) Acres, more or less. This is the same tract of land conveyed to me by W. H. Langley by DEED recorded in R.M.C. Office for Greenville County in Vol 404, page 221.
