than Three Thousand Two Hundred (\$3,200.00) - - Dollars in a company or companies satisfactory to the mortgagee from loss or damage by fire, and the sum of Three Thousand Two Hundred the said mortgagee, and that in the event the mortgagor... shall at any time fail to do so, then the mortgagee may cause the same to be insured and reimburse itself for the premium, with interest, under this mortgage; or the mortgagee at its election may on such failure declare the debt due and institute foreclosure proceedings.
