I, **Claud C. Calmes**

SEND GREETING:

Whereas, I, the said **Claud C. Calmes**

in and by **my** certain **promissory** note in writing, of even date with these Presents, **am** well and truly indebted to **Central Realty Corporation**

in the full and just sum of **Three thousand fifty and no/100 dollars (\$3,050.00)** to be paid **as follows \$45.00 on May 10, 1951 and \$45.00 on the 10th day of each month thereafter until paid in full with the privilege of anticipating any or all payments, said payments to be applied first to interest and then to principal.**

with interest thereon from **date** at the rate of **6** per centum per annum, to be computed and paid **monthly**

until paid in full: all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville and being known and designated as a part of Lot Number 16 of a Subdivision known as Vista Hills, a plat of which is of record in the R.M.C. Office for Greenville County, in Plat Book P at Page 149, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Ridgecrest Drive at the joint front corner of Lots 16 and 17, said point being 200 feet South-west of the Northwestern intersection of Wayne Street with Ridgecrest Drive, and running thence N 69-15 W 180 feet to a point at the joint rear corner of Lots 16 and 17; thence N 18-37 E 90 feet to a point at the joint rear corner of Lots 15, 16, 91 and 92; thence S 63-12 E 193 feet to a point on the Northwestern side of Ridgecrest Drive; thence S 27-42 W 70 feet to the point of beginning.
