WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Oregon Street, near the City of Greenville, being the major part of lot 6 of Block B, as shown on plat of the property of Kanatenah made by J. E. Serrine and Company on August 25, 1923, recorded in the R.M.C. Office for Greenville County in Plat Book F at Pages 130 and 13, and described as follows:

"BEGINNING at a stake on the Southern side of Oregon Street, 120 feet West from Fuller Street at corner of lot 7, and running thence with the line of said lot, S. 26-30 E. 165 feet to a stake; thence S. 63-35 W. 58 feet to a stake; thence N. 26-30 W. 165 feet to a stake on Oregon Street; thence with the Southern side of Oregon Street, N. 63-35 E. 58 feet to the point of beginning."
