all that tract or lot of land in the City of Greenville, Greenville Township, Greenville County, State of South Carolina. known and designated as Lot Number Two (2) of Block One (1) of Boyce's Addition to the City of Greenville, as shown on a map or plat thereof of record in the R. M. C. Office for said County in Plat Book "A" at page 90, reference to which is hereby made; said lot of land being described by metes and bounds as follows, to-wit:
