"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of <u>Greenville</u>, in <u>Paris</u> Mountain Township, at the southwest corner of the intersection of W. Decatur Street and Rodney Avenue and being known and designated as Lots Nos. 99 and 100 of the property of Margaret H. Beattie as shown on a plat thereof, as revised by Dalton & Neves, Engineers in April 1931, entitled Property of J. P. Rosamond recorded in the R. M. C. office for Greenville County in Plat Book H, page 186 and being described together, according to said plat, as follows:

"BEGINNING at an iron pin on the southwest corner of the intersection of W. Decatur S treet and Rodney Avenue, and running thence along Rodney Avenue, S. 64-45 E. 160 feet to an iron pin, joint corner of Lots Nos. 99 and 120; thence S. 22-30 W. 120.2 feet to an iron pin, joint rear corner of Lots Nos. 100 and 101; thence along the joint lines of Lots Nos. 100 and 101, N. 64-45 W. 165.8 feet to an iron pin on W. Decatur Street, joint front corner of Lots Nos. 100 and 101; thence along W. Decatur Street, N. 25-15 E. 120 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by R. H. Trammell and Thelma R. Trammell by their deed dated January 20, 1948 and recorded in the R. M. C. office for Greenville County in Vol. 334, at page 4."
