"BEGINNING at an iron pin on the western side of Butler avenue, which pin is 70 feet in a southerly direction from the intersection of Butler avenue and an alley, and running thence N. 69-05 W. 109.6 feet to an iron pin; thence N. 61 W. 7.75 feet to an iron pin; thence S. 20-38 W. 59.2 feet to an iron pin; thence S. 69-05 E. 117.3 feet to an iron pin on the western side of Butler Avenue; thence along the western side of Butler Avenue, N. 20-38 E. 58 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to Abner C. Chastain and Eunice Hughes Chastain by R. R. Stokes by deed dated September 30, 1946 and recorded in the R. M. C. office for Greenville County in Vol. 300, at page 15, the said Eunice Hughes Chastain having conveyed her undivided one-half interest to the mortgagor by deeds recorded in the R.M.C. office for Greenville County in Vol. 302, at page 139 and Vol. 379, at page 227."
