C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, School District 11-A, and designated as Lots Nos. 4, 5, 9 and the northeastern portion of Lot #10 on plat of the J. A. and Alma Bennefield property, by J. Q. Bruce, 5-8-49, and delineated as follows:-

Beginning at the joint corner of Lots 3 and 4 in the center of a surfaced road, and runs thence therewith N 50-00 E three hundred twenty (320) feet to the center of junction of said surfaced road with another unopened (formerly proposed) road; thence N 62-08 W five hundred twenty-eight (528) feet to a point in the center of the said unopened road even with the line of Lot No. 12; thence along the Willis line S 23-30 W two hundred ninety-three and seven-tenshs (293.7) feet, more or less, to the corner of the Willis lot on line of Lot No. 10; thence with the Willis line and the dividing line between Lots 3 and 4, S 62-08 E three hundred minety-three (393) feet to the beginning corner.
