That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Townshipand more fully described as follows:-

BEGINNING at a point in the read known as the Chandler Road (and on the line of H. P. Beam) which leads from the Augusta Road to Pelser and running thence along said road S. 75-40 W. 416.4 feet to a corner in said road; thence leaving said road and running by a new line N. 1-35 W. 500 feet to a stake; thence N. 24-50 E. 655 feet to a point in an old road on line of T.
