sold and released, and by these Presents do grant, bargain, sell and release unto the said Vesta Orr Abercrombie, her Heirs and Assigns forever, all that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as lot No. 74 of Camilla Park, Map No. 2, as shown by plat of same made by W. J. Riddle, Surveyor, December 1943, recorded in the RMC Office for Greenville County in Plat Book M, page 85, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Flora Avenue, joint corner of lots Nos. 74 and 73, and running thence with line of lot No. 73, S. 80-44 E. 200 feet to a stake; thence S. 9-16 W. 80 feet to an iron pin, joint corner of lots Nos. 74 and 75; thence with line of lot No. 75, N. 80-44 W., 200 feet to an iron pin on Flora Avenue; thence with Flora Avenue, N. 9-16 E., 80 feet to the beginning corner. This is a purchase money mortgage, being given to secure the credit portion of the purchase price.
