All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern side of Edwards Road, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as the southwestern 20 feet of Lot No. 6, all of Lot No. 7, and the Northeastern 15 feet of Lot. No. 8, of Block "B" of Mayfair Estates as shown on a plat of said subdivision recorded in the R.M.C. Office for Greenville County in Plat Book S at pages 72 and 73, and having according to said plat the following metes and bounds:

BEGINNING at a point on the Northwestern side of Edwards Road, which point is located S. 29-12 W. 30 feet from the joint front corner of Lots Nos. 5 and 6, and running thence a new line through Lot No. 6, N. 60-48 W. 150 feet to a point in the rear line of Lot No. 6, which point is S. 29-12 W. 30 feet from the joint rear corner of Lots Nos. 5 and 6; thence along the rear lines of Lots Nos. 29 and 28, S. 29-12 W. 85 feet to a point in the rear line of Lot No. 8 which point is N. 29-12 E. 35 Feet from the joint rear corner of Lots. Nos. 8 and 9; thence a new line through Lot No. 8, S. 60-48 E. 150 feet to a point on the Northwestern side of Edwards Road, which point is N. 29-12 E. 35 feet from the joint front corner of Lots No. 8 and 9; thence with the Northwestern side of Edwards Road N. 29-12 W. 85 feet to the point of beginning.
